5. APPROVAL OF MINUTES FROM LAST MEETING

7. CHAIRS REPORT

- Chair's Quarterly Meeting
 - J. Hunt met with new the MECP Director of the Source Protection Branch, Kirsten Corrigal.
- Quarterly Chairs Meeting Keith
 - K. Taylor noted a discussion on Communications and Outreach took place, highlighting Conservation Ontario's efforts, Ausable Bayfield Maitland Valley Source Protection Region's videos, and using education and outreach as a policy tool.

8. PROGRAM UPDATE

- Technical Rule Changes
 - K. Taylor noted the Phase II Directors Technical Rules have been approved, and we have already addressed the above grade fuel tanks in WHPAs and IPZs in our policy amendments.
 - K. Taylor added that we have considered changes to Road Salt Application in our policy amendments (Education and Outreach), but consultation with anyone affected by the Phase I and II Technical Rule changes is required.
 - Staff will be preparing a consultation plan, including early engagement for later this year, and preconsultation and public consultation likely next year.
- 2021 Annual Progress Reporting Update
 - K. Taylor provided a verbal update on the status of 2021 annual reporting.
- Section 51 Amendments
 - K. Taylor noted there was a Section 51 amendment to the Trent and Ganaraska Source Protection Plans in December, 2021.

10. FINAL POLICY IMPLEMENTATION CHALLENGES

Storage of Road Salt

- K. Taylor provided an update on how road salt storage will be effected by the new Technical Rules, and noted the committee has already decided to use Education and Outreach for Road Salt Application.
- M. Wooding confirmed that this has been noted as serious issue in other regions of the province, and supports the use of Education and Outreach given the difficulty in using prohibition.
- K. Taylor noted staff will return at an upcoming meeting with a recommendation for addressing the Technical Rule changes in regard to road salt storage.
- Snow Storage
 - K. Taylor provided an update on how snow storage will be effected by the new Technical Rules, but noted clarification is needed from the Ministry on the quantity of snow stored, and snow disposal facilities.
 - R. Straka inquired about snow storage on institutional lands and whether this is different from commercial. K. Taylor noted they'll follow up on this.
 - K. Taylor noted possible changes are Education and Outreach for smaller quantities, and a Prescribed Instrument Policy related to Snow Disposal Facilities that outlet to stormwater facilities.
- DNAPLS
 - K. Taylor provided an update on how the Technical Rules changes impact DNAPLs, noting the policy text will need to be revised to add a list of activities, and that consultation with businesses in the WHPA A, B, C and in IPZ or WHPA E with a vulnerability score of 9 or 10 will be required.
 - K. Taylor noted that the current policies are likely still appropriate, but for small quantities Education and Outreach may be more applicable.
- Waste
 - K. Taylor noted Ministry clarification is needed to address changes to the Waste policy.
- Stormwater
 - K. Taylor suggested that in order to update this policy, many updates to the Assessment Report may be required. The program coordinator suggested that there may not be the time or budget to address this for this round of amendments. More clarification is required from the Ministry.
- In summary, K. Taylor expressed that staff will need to look at the preamble to all policies and rewrite them to reflect the new rules where necessary.
