

OTONABEE-PETERBOROUGH SOURCE PROTECTION AREA – OVERVIEW

The Otonabee Region Conservation Authority (ORCA) is located within the Kawartha Lakes region of Ontario and encompasses the Otonabee, Indian and Ouse River watersheds, an area of approximately 1,951 square kilometers. For the purposes of drinking water source protection, an additional area of 1,414 square kilometers has been identified for the Otonabee-Peterborough Source Protection Area (SPA). This area includes the watersheds north of the Kawartha Lakes in Peterborough County; namely, Eels Creek, Sandy Creek, Mississauga River, Deer Bay, and Jack's Lake watersheds, as well as the Buzzard Creek watershed in Haliburton County. The total watershed area for the Otonabee-Peterborough Source Protection Authority is approximately 3,365 square kilometers.

The predominant physical features of the Otonabee-Peterborough SPA are: the Oak Ridges Moraine, Kawartha Lakes, Dummer Moraine, Peterborough Drumlin Fields and the karst

topography of the Indian River and Ouse River watershed areas.

The population within of the Otonabee-Peterborough SPA is estimated to be 143,205 with the majority of the population (55%) residing in the City of Peterborough (2001 census data). It is anticipated that the population within the SPA will grow at an average rate of 2.55 per cent per year to approximately 147,000 by 2012.

Within the Otonabee-Peterborough SPA, agriculture, forestry, recreation and urban development are the primary land uses. Agriculture accounts for approximately 40 percent of the land use, while forests/woodlands cover 48 percent, recreation/other is 10 per cent and urban areas cover 2 percent of the SPA.

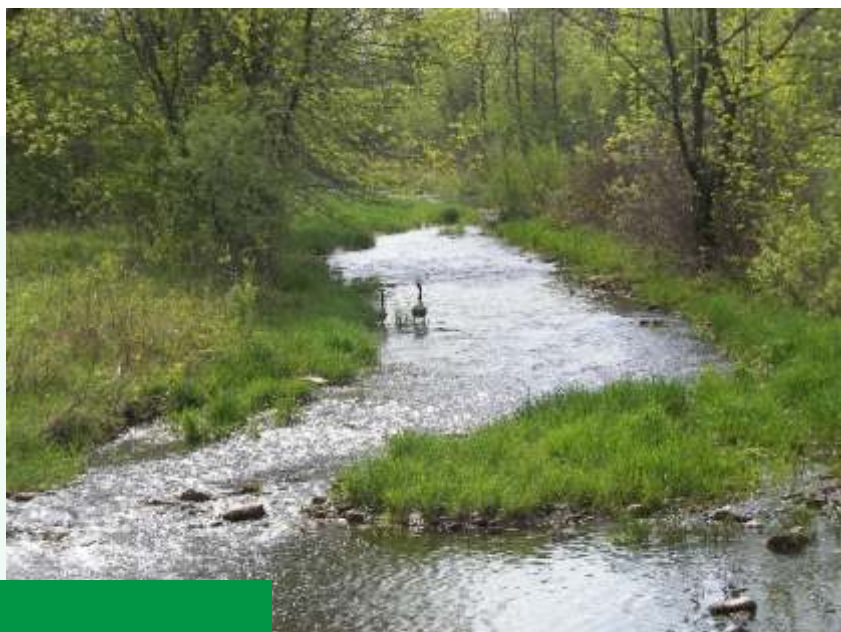
Peterborough and Haliburton Counties are premiere recreation destinations within Ontario. The beauty of the Kawartha Lakes and the Trent-Severn Waterway as well as other inland river

systems provide visitors with a variety of recreational opportunities including cottaging, camping and boating. Seasonal residences (cottages), Crown land, and recreational areas used for camping and other activities dominate the northern portion of the SPA on the Canadian Shield, while agriculture and larger urban areas dominate the southern portion. Land ownership in the northern portion of the SPA is approximately 20% privately owned rural and 70% Crown land.

The main factors affecting water quality within the Otonabee-Peterborough SPA include nutrient loading, sedimentation and bacterial contamination. The main sources include storm sewer effluent, roadway run-off, industrial effluent,



agricultural run-off, sewage treatment plant and septic system effluent. There are data and knowledge gaps including surface and groundwater quality, actual quantities of water takings, groundwater/surface water interactions, and significant aquifer recharge areas, and a long-term monitoring system. While water quality for municipal drinking water sources is relatively good, contaminants pose future risks if monitoring and preventative measures are not continued and expanded.

City of Peterborough	Peterborough	The Peterborough Water Treatment Plant, owned and operated by the Peterborough Utilities Services Inc., serves the City, the development of Woodland Acres (Smith-Ennismore-Lakefield) and the Peterborough Airport (Cavan Monaghan). It is a Large Municipal Residential System and serves a population of approximately 77,500 (24,695 connections).	Otonabee River
Municipality of Trent Hills	Hastings	The Hastings water treatment plant supplies water to the Village of Hastings and the Trentview Subdivision and is a Large Municipal Residential System. This plant services a population of approximately 1,250 people.	Trent River

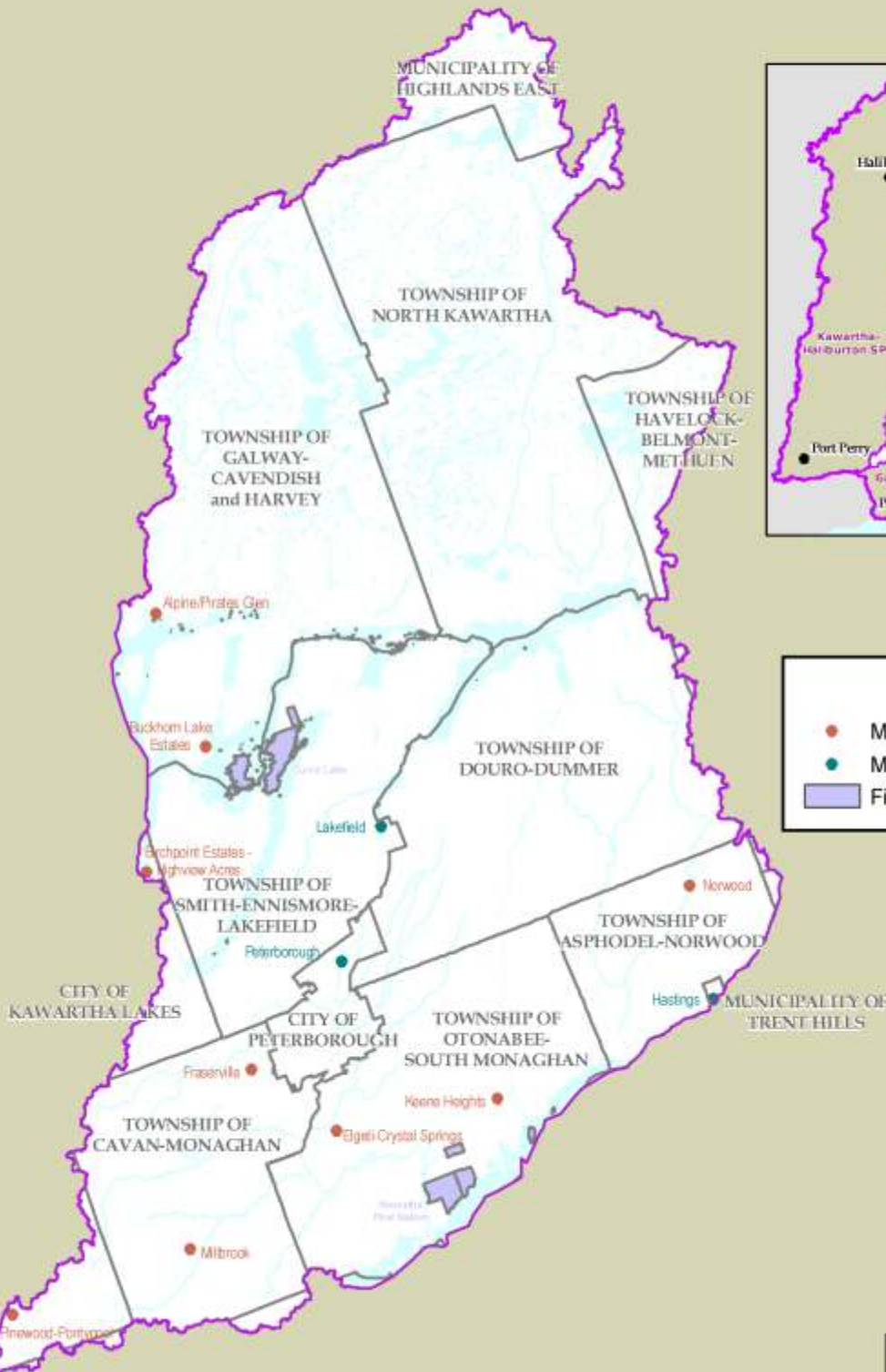


MAP – OTONABEE-PETERBOROUGH SOURCE PROTECTION AREA
